EDICT ON THE OPENING OF BANKRUPTCY PROCEEDINGS

On application of PricewaterhouseCoopers AG, Zurich, as the special representative of Gable Insurance AG, Vaduz,

bankruptcy proceedings are opened

on the assets of

**Gable Insurance AG, Bergstrasse 10, 9490 Vaduz
FL-0002.161.375-6**

by order of the Princely Court of Justice dated **17 November 2016**.

1.)

The legal effects of the opening of bankruptcy proceedings shall begin to apply on 19 November 2016, that is the day after the publication of the Edict on the Opening of Bankruptcy Proceedings in the *Amtsblatt des Fürstentums Liechtenstein* (Official Journal of the Principality of Liechtenstein) (that date being 18 November 2016), and these effects shall apply **on the entire territory of the EEA Member States and Switzerland**.

The bankruptcy proceedings shall also extend to any assets of Gable Insurance AG, Vaduz, registration number FL-0002.161.375-6, that are located in other EEA Member States and in Switzerland.

2.)

Batliner Wanger Batliner Rechtsanwälte AG, Am Schrägen Weg 2, 9490 Vaduz, is **appointed** as the Trustee in Bankruptcy. Communication with the Trustee in Bankruptcy shall take place using the e-mail address **gable@bwb.li**, which has been created specifically for this purpose.

3.)

All creditors of Gable Insurance AG are called upon to register **their claims** - stating the title and the claimed class (preferential claim, class 1 - 4) - **with the Trustee in Bankruptcy until no later than 01 September 2017**, stating the exact amounts of the claims and of the interest asserted and enclosing the **supporting documents** demonstrating their claims.

Creditors who register their claims later will have to bear the costs caused by this and will be unable to object to any claims that have been reviewed before.

4.)

The **general review hearing** is appointed for

Wednesday, 06 December 2017, 09.00 hours, courtroom 6.

at the Princely Court of Justice, Spaniagasse 1, 9490 Vaduz.

All creditors are called upon to bring the supporting documentation for their claims as far as such documentation has not already been enclosed with the registration of such claims.

5.)

All creditors who do not have an address for service in Liechtenstein are directed to nominate to the court **a person authorized to accept service** (this may be any individual, legal entity, or partnership with an address for service in Liechtenstein who or which has been authorized to accept the service of documents) **within 8 weeks**. **Note** that if no person authorized to accept service is appointed in time, documents will be served by depositing them at the court without any attempt to serve them (Art. 12, 9, and 25 ZustG¹).

6.)

All further publications concerning these bankruptcy proceedings will be made on the website of the Court of Justice (www.gerichte.li).

This court will effect the publication of the opening of bankruptcy proceedings in the **Official Journal of the European Union by way of edict** and will send the corresponding information to the EFTA SECRETARIAT in Brussels.

7.)

The Court of Justice will inform the **Liechtenstein Financial Market Authority** of the opening of bankruptcy proceedings and of the effects in terms of Art. 154 VersAG and will be directed to inform the supervisory authorities of the other EEA Member States forthwith about the fact that bankruptcy proceedings have been opened and about the effects of this.

8.)

The opening of bankruptcy proceedings shall be noted with the Bankrupt's real estate properties as well as in the Liechtenstein Public Register, the Register of Attachments, and all registers where intellectual property rights are entered into, stating the date of the opening of bankruptcy proceedings in all instances.

Any disposal of shipments, deposits, and credit balances or the like of the Bankrupt may only be carried out with the consent of the Trustee in Bankruptcy.

9.)

Liechtenstein law shall apply.
